Registration - Any payment received less than one week before the start of a class will result in paying the regular price (not early registration price) for the course. Anyone who registers less than one week before the class date must pay with a credit card. Registration will not be accepted on the day of the class. All registrants are responsible for being certain they comply with all course requirements prior to registration. This includes but is not limited to: pre-requisites, equipment requirements, physical requirements, participation, etc. All classes are subject to cancellation if minimal enrollment requirements are not met.

Cancellation - Any course withdrawal made by the registrant at least one week before the start of the course will result in a refund of the course fee less a \$25 administrative fee. Any course withdrawal made by the registrant less than 6 days prior to the course date will result in a 50% refund of the course fee. Any no-show or cancellation on the day of the class will result in no refund of any kind. Any course cancelled administratively will result in a 100% refund. Refunds will be issued in the same manner as original payment within ten (10) business days of course cancellation/withdrawal.
